JOB PATH WAS ESTABLISHED IN 1978 TO FIND WAYS OF ENABLING PEOPLE WITH DEVELOPMENTAL DISABILITIES TO MOVE INTO THE MAINSTREAM WORKFORCE AND WAS THE FIRST PROGRAM OF ITS KIND IN NEW YORK STATE AND ONE OF THE FIRST IN THE COUNTRY. TODAY JOB PATH USES "CUSTOMIZED EMPLOYMENT" STRATEGIES WHICH IDENTIFY THE SKILLS EVEN PEOPLE WITH THE MOST SEVERE DISABILITIES CAN BRING TO THE WORKFORCE AND WORK WITH BUSINESSES TO CREATE OR CARVE OUT A POSITION THAT WORKS FOR BOTH PARTIES. WE HAVE FOUND THESE STRATEGIES TO BE ENORMOUSLY EFFECTIVE: ABOUT 76% OF OUR ENROLLEES ARE PLACED IN JOBS AND RETAIN THOSE JOBS FOR 90 DAYS OR LONGER AND 83% RETAIN EMPLOYMENT FOR AT LEAST A YEAR.

THIS PAST YEAR JOB PATH PLACED 43 PEOPLE IN JOBS. WE ADDED A NUMBER OF

THE COMMUNITY SUPPORTS PROGRAM HELPS PEOPLE CONNECT TO VOLUNTEER JOBS AND SOCIAL AND RECREATIONAL OPPORTUNITIES IN THEIR COMMUNITIES. THE PROGRAM IS AN ALTERNATIVE TO GROUP-ORIENTED DAY PROGRAMS. EACH PERSON DEVELOPS A WEEKLY SCHEDULE BASED ON HIS/HER TALENTS, INTERESTS AND GOALS AND IS SUPPORTED BY JOB PATH STAFF AS THEY PARTICIPATE IN ACTIVITIES. FOR EXAMPLE, THIS YEAR ONE YOUNG WOMAN OBTAINED HER GED, AFTER DILIGENT WORK SUPPORTED BY HER JOB PATH MENTOR. IN ADDITION, WITH THE HELP OF HER STAFF, SHE WROTE AND ILLUSTRATED TWO CHILDREN'S BOOKS AND IS CREATING DISPLAYS FOR A LOCAL BOOKSTORE. THIS COMING YEAR SHE WANTS TO APPLY TO ART SCHOOL. THE PROGRAM SERVED 48 PEOPLE THIS YEAR.

WHILE GROUP HOMES OFFER SERVICES IN A SAFE AND HOMELIKE ENVIRONMENT, SUPPORTED LIVING ENABLES PEOPLE TO ESTABLISH THEIR OWN HOMES BY PROVIDING THE SUPPORTS THEY NEED TO MANAGE THEIR HOUSEHOLDS AND THEIR LIVES. THIS YEAR THE PROGRAM SERVED A TOTAL OF 31 PEOPLE.
